4. Review of recent trends on antibiotic use in primary care in Scotland – presentation

Most recent data presented on the trends in antibiotic use in primary care in Scotland. The presentation focused on recent trends on use of antibiotics commonly used for respiratory infection, antibiotic use in dentistry and progress against antibiotic use indicators.

## 6. SAPG guideline review update

Update provided on SAPG guidance which is either currently under review or due for review in 2024

Committee discussed progress on review of guidelines on the website and those currently in development including:

- Good practice recommendations for treatment of candidaemia and the use of antifungal agents.
- Good practice recommendations on use of triazole antifungal agents in chronic respiratory disease.
- Good practice prescribing recommendations for antifungal stewardship in haematolooncology.
- SIGN 160 Management of suspected bacterial lower urinary tract (UTI) infection in adult women.
- Chloramphenicol prescribing in adult patients
- Guidance on initial antibiotic management of neutropenic sepsis/febrile neutropenia in adult cancer patients (including haemato-oncology).

# 7. Antimicrobial companion app and move of guidelines to Right Decision Service (RDS) platform (paper 5)

Update provided on UKCA accreditation for gentamicin and vancomycin calculators and also highlighted process of the antimicrobial companion app moving to RDS platform.

The standard operating procedures for RDS content has been updated. There will be more visibility of authorship and governance processes and new guidance on accessibility.

Additional support will be available to boards for the transition which will be completed by early April.

#### Scottish Patient Safety Programme (SPSP)
